Operational Activities - Chief Bremner & D/C George:

The 12th annual SSIFR "Training in Paradise" educational event took place July 6th to 12th with ten different training courses. One course began July 6th and another began on July 9th and the rest on July 10th for an overall total of ten training courses being offered. A total of 96 Firefighters (23 SSIFR members) from across BC attended from 26 communities. Courses were held at the Ganges Fire Station, GISS and SSIFR Fulford Training Ground. Visiting firefighters and families attending the event enjoyed our island, shopping at local businesses, attending the market and eating out at many venues. In partnership with many other local agencies and businesses the event once again was a huge success. This annual event continues to permit our local firefighters to remain on Island with their families to obtain training which along with other cost saving measures save taxpayers' dollars in comparison to going off island for such training requirements. A huge "Thank you" to everyone involved, we look forward to the 13th annual "Training in Paradise"

As noted in our monthly & yearly incident reports F/R (Medical) calls are the highest category of calls we respond to. On average F/R calls are experiencing five members attending. During the day time 7am to 5pm it is primarily career staff who handle them with a few POC's assisting. From 5pm to 7am primarily POC members handle them with the Duty Officer. An average timeframe for each F/R call is 1 hour.

During July the "Duty shifts" were filled in the following manner; Career – 23 shifts, Chief – 6 shifts, D/C – 2 shifts.

Station & Apparatus: We continually monitor & repair each station for ongoing structural / operational readiness.

Training Division Report - A/C Jamie Holmes:

Recruit Firefighters are continuing their learning right through the summer adding Auto Extrication and Ground Ladders to their skill set. With half the year completed, the recruits are realizing the commitment it takes to learn all proficiencies it takes to stay safe on the emergency grounds.

Our regular members worked together on a auto extrication scenario, rappelling off the training building, wrapping the month up with a major scenario combining Auto X with Rope Rescue during an over the bank Motor Vehicle Incident.

On the special operation front the Rope Rescue team, Pump team and the Auto X team both held practices to work on skills maintenance and efficiencies.
