## Operational Activities: Chief Bremner & D/C George;

Station repairs: we continually repair and monitor each station for on-going structural / operational issues.

Ventilation System installs: have been completed and are operational at all three stations.

Occupational Health & Safety Committee Report: Meeting minutes are posted on the OH&S bulletin board for review.

## Training Division Report: A/C Jamie Holmes;

The recruits continued their basic training, learning how to use their Self Contained Breathing Apparatus. It is equally important for us to teach them about the mental hardships of the job, so we introduced them to our Critical Incident Stress Management program in early March. Our CISM in-house program teaches recruit firefighter to recognize when we need to help each other, or get help ourselves because of the stresses we see during our emergency activities. The recruits also completed Incident Command 100 online through the Justice Institute of BC.

Our regular members took part in table tops scenarios to work on real life strategies and tactics, big water scenarios to see how quickly we can get large volumes of water to the seat of a fire, and emergency medical training in conjunction with BCAS and PARC staff at the Rainbow Road Pool. We wrapped up the month with a full department scenario putting in to practice the skills that were reviewed throughout the month.

On the special operation front the Rope Rescue team and the Auto X team both held practices to work on skills maintenance and efficiencies. Our water rescue team also met this past month and familiarized with the boat and required equipment. Two members trained in Victoria with the CRD Hazmat team reviewing the protocols for a chlorine spill and reviewing gas detection equipment.
